

Catch-Up Funding Strategy 2020 -21 to be cross referenced with Pupil Premium Strategy

Our approach in this academic year is to focus on the impact of COVID 19. The Catch-up Funding and Pupil Premium Grant will be combined to provide sufficient support and staffing to address the needs of both children in receipt of PPG and those additional children adversely affected by COVID 19. As some of these children will be in both categories a coherent approach is necessary to ensure no child in need is overlooked.

Identified Impact of COVID 19 and Lockdown

Writing

- Children are demonstrating a lack of stamina, impacting motivation
- Children's motor skills and hand strength has deteriorated
- More time being needed to embed punctuation and grammar skills

Reading

- For those children who continued to read during partial school closure, genre choices were often limited and often there was not enough discussion around texts to develop comprehension and inference skills to an expected level
- Many children did not continue to read enough. This has impacted on fluency and comprehension

Maths

- Specific content has been missed which will be built into this year's curriculum
- Children's fluency in mathematical skills has been negatively affected

Emotional Well-Being

- Although the majority of children appear to have settled back into school routines smoothly, some have found separation from family members difficult
- A minority have struggled to readjust to the routines and expectations of school
- The school is mindful of the possibility of ongoing anxiety as COVID 19 dominates national life with ongoing restrictions and limitations to family and wider social connectivity

Foundation Curriculum

- As teachers plan foundation subjects they are aware that some links with previous knowledge cannot be assumed as topics were not taught in the last academic year. Opportunities to review key knowledge will be planned to address this

How will the school measure the impact of Catch-Up Funding?

At Great Totham every child's progress is tracked. The usual cycle of assessment, moderation, data collection and evaluation enables early identification of need, support and planned intervention.

Year teams work both across Key Stage phases and with senior staff to discuss academic outcomes regularly and consider how best to meet identified children's needs.

Governors will monitor, challenge and review the Catch-Up Funding Strategy. They will consider impact of initiatives, changing pupil needs and how best the school plans to meet them.

Internal data and end of Key Stage SATs results will be analysed and compared to targets and historical data.
